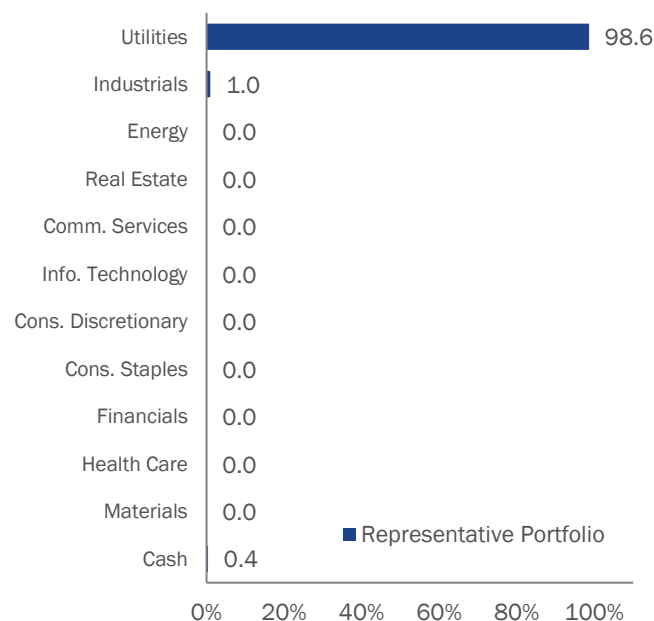

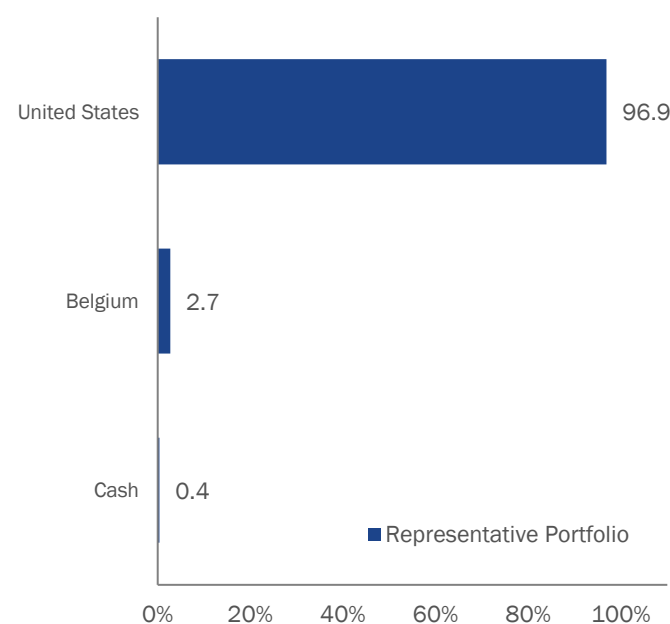

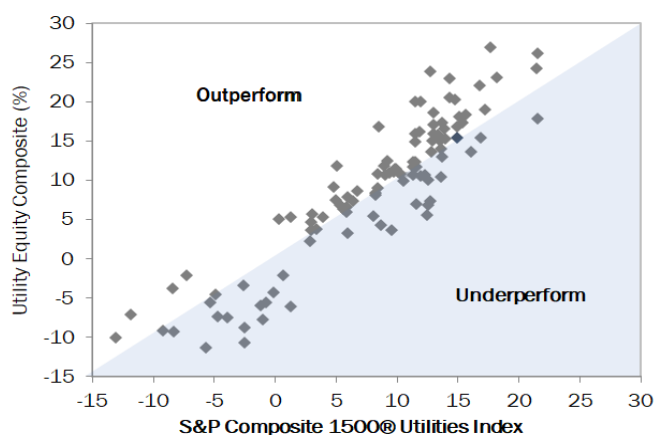

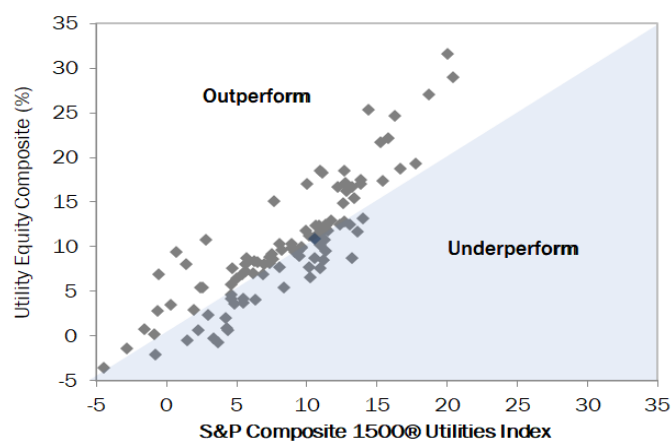
Net of fee*, quarterly data from 12/31/94 to 6/30/26
